

## AML rates effective June 1, 2021

The following wharfage and dockage rates are for vessels that berth at an AML pier and for cargo that crosses an AML pier to or from a vessel other than one operated by AML. These are not rates that apply to AML cargo that moves on an AML pro. These rates can be used on charters operated by AML.

### WHARFAGE

Wharfage is the fee to pass cargo over AML's wharf or pier. Wharfage does not provide for cargo handling activities, labor or equipment. Wharfage shall include up to 5 days of storage at AML's terminal subject to space availability. AML may elect not to grant the free storage time for certain cargos and may decline to provide any storage at its sole discretion and may require immediate removal of cargo from its terminal(s). When applicable, storage charges shall be at the rates listed in AML's Surface Transportation Board tariffs.

### DOCKAGE

Dockage is a fee for berthing a vessel at AML's pier. It does not provide for any cargo handling service. Wharfage charges are in addition to Dockage. Dockage availability/permission is at AML's discretion as determined by the local Port Manager or an officer of AML. Dockage at AML's pier(s) is subject to the terms of AML's terminal access agreement which shall be executed but when in absence of a signature, customer agrees to by docking at AML's pier. In any case, when accessing AML's pier or terminal the vessel owner is responsible for damage to AML facilities and shall indemnify and hold AML harmless for any and all vessel damage for whatsoever cause.
