RULE 100

Except as otherwise provided herein, this Tariff is governed by the following publications, including supplements thereto or subsequent re-issues thereof :

- B. Alaska Marine Lines, Inc., General Rules, Commodity Group Descriptions and List of Participating Carriers, Tariff No. 100, STB AKMR 100, series, except as noted.



EFFECTIVE: May 23, 2002

APPLICATION OF ARBITRARY FUEL SURCHARGE:

RULE 345

Except as specifically indicated in individual rate items and exceptions noted herein, all shipments and accessorial charges are subject to an Arbitrary Fuel Surcharge of ▼ twelve and one half percent (12.50%). Multiply rate by 1.125.

NOTE 1. For rates in cents, fraction will be as follows: Fractions of less than 1/2 cent will be dropped and fractions of 1/2 cent or more will be rounded to the next whole cent. For rates in dollars, fractions of dollars will be rounded as follows: Less than .50 will be dropped .50 or more will be rounded to the next whole dollar.

NOTE 2. Where the rate or charges is published in dollar and cents, apply the equivalent in cents.

NOTE 3. Reference to Tariffs, Items, Notes, Rules, etc. will be as follows:
