Please read and initial ALL boxes below:

	Game meat is properly packaged or tarped. Loose game bags on a pallet will not be accepted.
	I understand that boxes are not guaranteed upon drop off and may be unavailable during peak season. If boxes are not available, I agree to pay \$1.30/lb. for my shipment.
	My contact information is clearly visible/affixed to the outside of my shipment and is written clearly and legibly on my air waybill (AWB).
	Flight schedules may change. My game meat, fish, or gear may not return on the flight I expect.
	I have tagged my antlers with my name and contact information. One air waybill (AWB) per hunter.
	I understand rates differ for sturdy, stackable packaging versus tarped meat. Antlers and ivory will be charged \$0.65/lb.
	I understand I have 24 hours to pick up this shipment once it arrives in Anchorage. After 24 hours, storage is \$150 per pallet per day. I am responsible for the fee even if an expeditor picks up late.
	Freeze and chill storage are first come, first served. I have clearly marked freeze or chill on both the airway bill and the freight. I have signed my airway bill and kept a copy.
	I understand chill temperature control is unavailable during peak season (September). Only freezer storage is offered.
	Hunting and camping gear must remain separate from game meat and fish, and I understand they may ship separately.
	I understand payment is required before my shipment can be released to a third party or expeditor
	If a third party or expediting company is picking up in Anchorage, I have completed the release information below.
	I understand there is no pickup in Anchorage on Sundays. I will not pick up my shipment in Anchorage until I have been notified by Anchorage Customer Service that it is ready for pickup.
	I understand my game meat, antlers, capes, ivory, and fish have no commercial value. This shipment moves at SHIPPER'S RISK. Claims cannot be opened, and chipped or broken antlers/ivory cannot be claimed.
